Assumption of Risk

In consideration of being allowed to participate as a "steel shooter" of steel targets at the Eustis Gun Club, I understand, accept, and agree that the risks involved at a gun range are significant and may include personal injury, risk of death, and/or damage of personal property. I CHOOSE TO PARTICIPATE DESPITE KNOWING THE INHERENT RISK INVOLVED. I PERSONALLY HEREBY ASSUME ALL INHERENT RISKS TO MY PERSON OR PROPERTY.

Waiver and Release

In consideration of the Eustis Gun Club, Inc.'s agreement to allow me to use its facilities, I, for myself and on behalf of my heirs, assigns, personal representatives, and next of kin voluntarily agree to HEREBY RELEASE, WAIVE, DEFEND, INDEMNIFY, HOLD HARMLESS, and FOREVER DISCHARGE, the Eustis Gun Club, Inc. and its employees, officers, agents, members, contractors, other participants and any other persons or entities ("Release") from any and all claims. WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, loss of services, or loss or damage to person or property, or otherwise, associated with my presence or participation, whether arising from the negligence of the Releases' or otherwise, to the fullest extent permitted by law.
